Concluding Remarks – Bishop Bill

Some congregations disagree with the Synod Approach to diversity, equity, inclusion and belonging.

Quotes from **Stuck Together** shared with Synod Council April 22, 2023

It pays to listen closely to someone with whom we disagree, and to convey respect. "Deep listening is an act of surrender," writes civil rights activist and Sikh faith leader Valarie Kaur. "We risk being changed by what we hear." She allows that it is extremely difficult to listen well to someone whose beliefs we find abhorrent or terrifying. But the most critical part of listening is asking what is at stake for the other person. As Kaur notes, "The goal of listening is not to feel

empathy for our opponents, or validate their ideas, or even change their mind in the moment. Our goal is to understand them." What life experiences or deep needs shape the perspectives of the other person? Kaur emphasizes that listening well "does not grant the other side legitimacy. It grants them humanity—and preserves our own." (p. 99)

Using such freedom requires faith communities to exercise discernment, a skill that pastor and theologian Richard Kauffman believes the church needs to recover. "Too many Christians have made a fateful turn from dealing with conflictual issues through discernment to using advocacy instead," he asserts. "Discernment is collaborative, while acknowledging difference and disagreement. Advocacy assumes that my position is correct, and the rest need to come over to me." 2 Advocacy may be helpful, but in the end, the faith community functions best by corporate discernment. (p. 109)

In his recent book The Church of Us vs. Them, evangelical theologian David Fitch laments the current "strife, antagonisms, and vitriol" in North American society. But he grieves even more that Christians "appear to be caught up in the same antagonism and disgust for one another that is evident elsewhere." Addressing that disfunction within the church is essential for proclaiming the gospel in society, Fitch contends. To be effective, "we must first become the place the world can recognize as beyond enemies. We must first deal with our own antagonisms. Once freed, we then can enter the world in peace, opening up space for Christ to work." (p. 113)

# **ACTION - SC/2023/08**

Executive Committee is requesting Synod Council ratify Action EC/2023/04: Pastor Karleen Jung and Pastor Grace Alworth be designated Disaster Resiliency Coordinators pursuant to their work as Relief Coordinators responding to2022 tornadoes in the Commonwealth of Kentucky. Compensation in the amount of\$50,000.00 (allowed administrative costs included in the Lutheran Disaster Relief grant of 2022) dispersed in the amount of \$25,000.00 to each Pastor. Motion Carried
